General Info & Process

Planning and Development Services is responsible for civic addressing in the City of Prince Albert.

The Civic Addressing Policy ensures all civic addressing in the City of Prince Albert follows a logical format and adheres to certain guidelines.

The purpose of the policy is to:

- Assign property identification numbers in order to maintain a complete and consistent civic addressing system;
- Ensure the municipal wide system for civic addressing is upheld in order to facilitate the operation of emergency services systems;
- City administration can maintain suitable records and notify appropriate agencies; and
- The City's civic addressing format is corresponding with Canada Post where appropriate to aid in efficient and reliable delivery.

Request for a Civic Address Change

If you are interested in changing your civic address, a Civic Address Change Application form must be completed along with the application fee of \$50.00. If you are not the owner of the property, owner authorization is required in order for the application to be considered.

All applications for an address change must be accompanied by a substantive reason for the change and cannot be based on personal preference.

Approval of Requests

Administration will review the application and determine if the requested change is for a substantive reason (e.g. confusion for utility companies or Canada Post with a similar address). If it is determined that the request is acceptable, Administration will contact utility companies for feedback.

If approved, all additional fees related to the change, including those for external agencies such as Canada Post, utility companies, etc. will be the responsibility of the applicant.

If approved, the applicant or owner is responsible for updating their accounts with the appropriate authorities such as Canada Post, utility companies, etc.
