NOTE:

1. AN ELIGIBLE NOMINATOR MUST BE A VOTER OF THE SEPARATE SCHOOL DIVISION IN ACCORDANCE WITH SUBSECTION 36(2) OF *THE LOCAL ELECTION ACT, 2015* AS FOLLOWS:
 - “36(1)(d) subject to subsection 2, in the case of a school division:
 - (i) has resided in Saskatchewan for a least six consecutive months immediately preceding the day of the election; and
 - (ii) has resided in the school division for at least three consecutive months immediately preceding the day of election:
 - “36(2) To be eligible to vote in any election held in a separate school division, the person shall, in addition to the requirement set out in subclause 1(d), be of the religious faith of the minority that established that separate school division, whether Protestant or Roman Catholic, and, on being registered as a voter in that separate school division, that person is not eligible to vote in any other school division.”
2. A DEPOSIT IN THE AMOUNT OF \$100, IN THE FORM OF CASH, DEBIT OR CERTIFIED CHEQUE PAYABLE TO THE CITY OF PRINCE ALBERT, MUST ACCOMPANY THE NOMINATION FORM WHEN SUBMITTED TO THE NOMINATION OFFICER.
