Call for Photographers: *Pride in Pictures* Mural Project

1 Background

The Parks, Recreation, and Culture Department through the Municipal Cultural Action Plan have created a Photography Mural Project, *Pride in Pictures*, for our City to convey the Indigenous roots, diversity, strengths, assets, and pride of our city through a mural collage of local photographer's photos. This mural project will beautify, preferably outdoors, a building in a highly visible location or somewhere easily accessible to the public (to be determined).

This initiative links to the City's Municipal Cultural Action Plan, specifically:

- Cultural Goal 1: Honour the past and provide a balance in this narrative of both the positives and the challenges that have occurred when sharing our story.
- Cultural Goal 4: Ensure that all nations, communities, newcomers, and individuals are welcomed and celebrated in the community.
- Cultural Goal 5: Promote and communicate cross cultural understanding and learnings across nations, communities, newcomers, and individuals.
- Cultural Goal 6: Ensure a culturally vibrant community by supporting existing volunteers and organizations and promoting new partnerships.
- Cultural Goal 9: Recognize, strengthen, and honour the artistic and cultural community and the significant role it plays in developing and enhancing Prince Albert's cultural make-up and identity and beyond.
- Cultural Goal 10: Strengthen and enhance the downtown as a major cultural and economic hub to create a culturally vibrant community.
- Cultural Goal 11: Continue to invest in cultural initiatives and support other organizations and individuals that strive to make Prince Albert a vibrant cultural community.

It also addresses goals of the Public Art Policy, and efforts towards a beautification plan for our city.

2 **Objective(s)**

The City of Prince Albert is seeking photographs from local photographers. The Artists will provide the photos in a JPEG format, with a minimum file size of 2MB. With the help of lead local artists Alex Powalinsky and Lisa Halsall, the chosen photographs will be collaged into a permanent mural and installed on a local building (to be determined). Please note that your photo may be cropped to fit within the design. Each artist can submit a maximum of 3 photographs.

3 Eligibility

This call is open to photographers in Prince Albert and surrounding area (30 km radius). We encourage submissions from artists that are typically underrepresented including BIPOC (Black, Indigneous, and People of Colour), LGBTQIA2S+ identifying individuals, deaf persons, and persons with disabilities. 6 Requirements | Scope of Work

The photography mural project is intended to benefit our City to:

- Provide a bright and colourful display of art, enhancing the streetscape
- Showcase and celebrate the culture, heritage, diversity, and natural beauty of our City and residents
- Provide local artists with an opportunity to submit photographs for the mural
- Promote positivity and pride

Photograph Mural Theme

The submitted photographs should:

- Celebrate the culture, heritage, diversity, and natural beauty of our City's residents, promoting positivity and pride in our City; and/or,
- Foster connection, pride and belonging; and/or,
- Uplift our Indigenous, immigrant and newcomer personal and collective identities.

Technical Requirements

- All photographs must be original to the artist for the purpose of this call.
- All photographs featuring individuals should have a multi-media release form signed and dated by the featured individual (or parent/guardian) in the submitted photograph (see attached multi-media release form).
- Final photograph submission should contain appropriate levels of details and scale for viewing by pedestrians.
- Photographs should be provided as a digital rendering (jpeg format, minimum 2MB file size).
- Photographs must follow the mural specifications noted below.

Mural specifications

- The mural dimensions are to be determined, based on the size of the location's wall.
- The design and photographs will not include text, political or religious figures, and/or logos
- The product will be a printed vinyl sheet

About Prince Albert:

- Prince Albert is a vibrant and innovative municipality that prides itself on being a family focused community. Situated just minutes from lake country the City of Prince Albert is a recreational paradise that offers all the benefits of big city amenities including access to arts, entertainment and unique cultural experiences. Prince Albert is the proud home of a diverse offering of highly skilled professional sports and recreation organizations, an engaged and growing arts and cultural community and committed and passionate non-profit organizations.
- Prince Albert is the third largest City in Saskatchewan and a hub of health care, education, retail and infrastructure servicing upwards of 195,000 people in Prince Albert and central and northern Saskatchewan. We are located in the broad valley of the North Saskatchewan River near the geographical center of the province, where the agricultural prairie of the south and the rich forest belt of the north meet. Much of Prince Albert is built on the sloping south bank of the North Saskatchewan River while the north bank provides a spectacular view of mixed forest, typical of northern Saskatchewan.
- Located in the heartland of northern Saskatchewan, Prince Albert is located in Treaty 6 territory and the homeland of groups who have called the Prince Albert area home for thousands of years. These Indigenous groups are the Woodland Cree, Plains Cree, Swampy Cree, Dene and the Dakota and Métis Nations. Prince Albert has one of the highest Aboriginal (First Nations, Métis and Inuit) population ratios in any Canadian City (44.65% Census 2021).
- We are a diverse community with a large Indigenous population, several unique and celebrated cultures, and a growing immigrant population.
- Research conducted by Real Estate Company <u>Calgary.com</u> revealed that Prince Albert is NUMBER ONE for park space in Canada. According to the recent study, 20% of Prince Albert is used as parkland with a green score of 100/100. Scores were based on how much parkland, green area, and gardens cities have.

 - Briefly describe your experience as a photographer and prior public art experience.
 - Briefly describe each of your photographs submitted

- 1 digital rendering (jpeg format) of each image for the proposed mural design (maximum 3 photographs per artist);

8 Budget

The Project Budget is \$250 per selected Photographer, regardless of the number of photographs that get chosen to be a part of the mural. This includes the creation of the artwork, as well as any other expenses incurred by the artist for the design, travel, etc.

- 2. The City of Prince Albert reserves the right to change or cancel the Call for Photographers without notice.
- 3. Should a dispute arise from the Terms and Conditions of this Call for Photographers regarding meaning, intent or ambiguity, the decision of the City of Prince Albert shall be final.

- 4. Any submission is not necessarily accepted.
- 5. The rights of the parties shall be governed by and the contractual terms shall be interpreted in accordance with the laws of the Province of Saskatchewan.
- 6. The City of Prince Albert is governed by *The Cities Act* and designated as a Local Authority pursuant to *The Local Authority Freedom of Information and Protection of Privacy Act (LAFOIP)*.
